Rhapsody Rotorua Photo and Video Competition

Terms and Conditions

1. To enter this competition entrants are required to submit a photo or video taken at Rhapsody Rotorua 2026 on their WorldStrides tour. Entrants will be required to submit their entries via an online submission portal where they will also have to submit their personal details including their name, school name, tour location, address, email address and the photo/video location.
2. By entering the competition, entrants agree to abide by these Terms and Conditions.
3. The Terms and Conditions of this competition are governed by the laws of the State of Victoria.
4. The competition is being run by WorldStrides at 264 Keilor Road, Essendon North, Victoria, 3041.
5. The competition is called the “Rhapsody Rotorua Photo & Video Competition” and commences at 9am Australian Eastern Standard Time (AEST) on Tuesday 4 August 2026.
6. The closing time for entering the competition is midnight AEST on Sunday 16 August 2026.
7. Entry to the competition is limited to Australian residents only. Prizes will not be shipped overseas.
8. Entrants under the age of 16 years must obtain parental consent to enter the competition and must declare on the Competition’s online entry form that he or she has his or her parent’s or guardian’s consent to enter the Competition.
9. Entries may be submitted to up to two (2) of the categories below, each of which will be judged against different criteria. The categories are:
 - a. Photo category – Share your best photo from Rhapsody Rotorua! Whether it’s a breathtaking moment during an activity, a fun shot, a selfie with your mates, a performance, or a memory that made the trip unforgettable, we want to see the moments that capture your Rhapsody experience!
 - b. Video category – Bring your Rhapsody experience to life! Create a video that captures your favourite moments, whether it’s a Tik-Tok-style recap, a montage of highlights, behind-the-scenes footage from concerts, interviews with your friends about their experience, or your own creative take on the week. Have fun and show us what made Rhapsody unforgettable!
10. There are no limits on how many photos or videos you can submit to each category.
11. Entrants can only win one prize category. Where an entrant’s work would otherwise place in more than one category, WorldStrides will award that entrant the higher-value prize, and the next-highest-placed eligible entry in the other category will receive that category’s prize instead.
12. Photos and videos that are submitted in connection with the contest will only be eligible if they:
 - a. Feature the entrant experiencing activities on their itinerary
 - b. Are in colour



- c. Are submitted during the contest period
 - d. Contain only “Original Content” of the entrant. “Original Content” means photos and/or videos that are created by the tour participant, and not photos and/or videos that have been created, produced, or edited by another party. WorldStrides will consider only those Photographs and Videos that meet all of these criteria, in the sole discretion of WorldStrides. WorldStrides reserves the right, in its sole discretion, to disqualify Photographs or Videos which it determines at any time in its sole judgment to fail to meet any of these criteria.
 - e. Entrants must obtain consent from all parties included in the submitted photo or video. Where any identifiable person in the submitted photo or video is under the age of 18, the entrant must obtain the consent of that person’s parent or legal guardian. By submitting an entry, the entrant warrants that all such consents have been obtained, and agrees to indemnify WorldStrides against any claim, loss, or expense arising from a breach of this warranty.
 - f. Do not contain any inappropriate behaviour, unlawful activity, drinking, nudity or swearing, in the WorldStrides’ sole discretion
 - g. Must use music legally. Students can create their own music, get written permission from the artist or download royalty free music.
13. The winner of the photo category will receive a \$100 JB Hi-Fi Voucher.
 14. The winner of the video category will receive Sony WH-CH720N Wireless Noise Cancelling Headphones (valued at \$259.95), colour of your choice, or if you’re submitting a group video, you’ll receive a \$250 JB Hi-Fi Voucher. Where a group video wins a prize, WorldStrides will provide a single voucher to be shared among the group as they see fit; WorldStrides is not responsible for apportioning a group prize among group members.
 15. The runner-up of the photo category will receive a \$50 JB Hi-Fi Voucher.
 16. The runner-up of the video category will receive a \$50 JB Hi-Fi Voucher.
 17. Entry to the competition is free. Entrants will be responsible for all costs associated with entering the competition, which may include costs associated with accessing the internet.
 18. Prize winners will be chosen by WorldStrides’ team of creatives, based on image composition, image resolution and overall quality, candidness, significance of content, originality, creativity, and overall presentation.
 19. Other technical judging criteria for video include – simple editing, no excessive zooming or transitions, no shaky footage, clear and engaging audio without background noise, only one aspect ratio and orientation - must be either portrait 1080x1920 (9:16 aspect ratio) is preferred or landscape 1920x1080 (16:9) is also accepted.
 20. The prize winner will be contacted by 28 August at the email address supplied by the entrant on the entry form.
 21. If the prize winner does not respond to claim the prize within fourteen (14) days of the selection, a re-selection will be conducted within twenty one (21) days of the original selection date, in the same location, and with the same method. Re-selection will continue in the same manner until all prizes have been claimed by prize winners.



22. The prize may be collected in person by the prize winner or may be mailed/couriered.
23. If a prize winner who has been contacted and been made aware of their prize winning and has agreed to collect the prize or for which collection is the only method for receiving the prize, does not collect the prize within twenty-one (21) days of this contact, a re-selection will be conducted within thirty (30) days of the original selection date through the same method.
24. The prize winner may be required to provide evidence of their identity (such as photographic ID, birth certificate or current passport) when receiving the prize.
25. The prize is not transferrable and cannot be redeemed or exchanged for cash or any other item.
26. The prize winner's first name and last initial (e.g. "Jordan S.") will be published on WorldStrides Social Media pages (Instagram, Facebook and LinkedIn). Where the prize winner is under the age of 18, publication of their name, image, or video on Social Media is subject to separate written consent from a parent or legal guardian, obtained after the winner is selected and before publication. By entering the competition, entrants who are 18 or over grant WorldStrides permission to use their first name and last initial on Social Media.
27. Entry into the competition signifies acceptance of all conditions. Entrants are required to abide by the Terms and Conditions as presented.
28. Entry into the competition signifies acceptance of all conditions by the parent or guardian on behalf of entrants under the age of 16. The awarding of the winning entry to an entrant under the age of 16 is subject to confirmation of parent or guardian consent to these terms and conditions.

To the maximum extent permitted by law, WorldStrides is not liable for any loss, damage, or claim arising from technical failures, or lost, late, or corrupted entries, or events beyond its reasonable control. Entrants agree to indemnify WorldStrides against any claim, loss, or damage arising from their breach of these Terms and Conditions.
33. WorldStrides reserves the right, at its sole discretion, to amend, suspend, or cancel this competition, or to disqualify any entrant or entry, at any time, including where it reasonably suspects fraud, technical interference, or a breach of these Terms and Conditions.
